In continuation to this Ministry's letter dated 20.08.2016 granting conditional permission for increase of intake capacity in MBBS Course from 100 to 150 at Maharashtra Institute of Medical Sciences & Research, Latur for the academic year 2016-17 on the basis of approval communicated by Supreme Court Mandated Oversight Committee on MCI (OC) and after considering the contents of MCI letter No.MCI-37(1)(RI-93)(UG)(Med./165518 dated 31.01.2017 sent after compliance verification assessment, I am directed to confirm the conditional permission issued vide this Ministry's letter dated 20.08.2016 for 2016-17 and remove the conditions imposed there on. MCI is also being requested to return the additional Bank Guarantee of Rs. 2 Cr. submitted by the College in the Ministry as per the conditions laid down by the OC, which is now in possession of MCI.

- 2. Further, I am directed to convey the approval of the Central Government for renewal of permission for admission of 2nd Batch against the increased intake i.e. from 100-150 in MBBS course for the academic year 2017-18 at Maharashtra Institute of Medical Sciences & Research, Latur under Maharashtra University of Health Sciences, Nasik.
- 3. The permission is valid for one year and for admitting only one batch of MBBS students against increased intake during the academic session 2017-18. The next batch of students in MBBS course against increased intake will be admitted in the college only after permission of Central Government for renewal.
- 4. The Government Medical Colleges (except those located in J&K, Andhra Pradesh & Telangana States) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.
- 5. Admissions made in violation of the above conditions will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.
- 6. Discrepancies, if any, may be immediately brought to the notice of MCI and the Central/State Government.

Sir/Madam,

I am directed to inform that an assessment to assess the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Maharashtra Institute of Medical Sciences & Research, Latur was carried out by the Council's assessors on 18th July, 2017. The said assessment report was considered by the Executive Committee at its meeting held on 30.08.2017 and it was decided as under:-

"The Executive Committee of the Council considered the assessment report (18th & 19th July, 2017) and decided to recommend that recognition of MBBS degree granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Maharashtra Institute of Medical Sciences & Research, Latur be continued restricting the number of admissions to 100 (One Hundred students.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April, 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ..

- (2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 25.10.2017.

It is further to inform you that your institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material etc. throughout, as stipulated in Regulation of Medical Council of India. In case false/wrong declaration of fabricated documents have been used for procuring the approval of Continuation of recognition by the Council and the said misconduct is brought to notice or comes to the knowledge of MCI at any stage, your institution is liable not to be considered for approval of continuation of recognition with the annual intake capacity of 100 students and this approval is also liable to be revoked.
